#### Prison death court hearing set for two days in June

A preliminary hearing in the case of a man charged with the murder of a fellow inmate is set for two days this June. Brandon Blake Colford, 23, of Blackville appeared via video link in Miramichi provincial court Friday afternoon from the Special Handling Unit of the federal penitentiary in Sainte-Anne-des-Plaines, Que., outside Montreal. (...) Colford is charged with the second-degree murder of 27-year-old inmate Calvin Clifford Kenny while both men were incarcerated at the Atlantic Institution in Renous. (...) Colford is serving a life sentence for second-degree murder in the 2016 slaying of Michael Mark Ryan of Miramichi. (...) Miramichi Leader

#### Man charged in bank heist was robber just out of jail

A man with a history of committing armed robberies who had just got out of prison is back behind bars. Yves Groleau is charged with committing two bank heists in Montreal just before Christmas while living at a halfway house. The 61-year-old got out of a federal penitentiary just weeks before. He made his first appearance before a judge on Boxing Day at the Montreal courthouse. He faces 13 new charges. (...) Groleau was arrested alone shortly after the second robbery. When he was charged, he listed Maison Essor, a halfway house on Lajeunesse St., as his home address. It became his home sometime after Nov. 7, when Groleau appeared before the Parole Board of Canada to ask that the suspension of the statutory release he qualified for in March be lifted. It was a process Groleau is not unfamiliar with: according to his parole records, he has seen previous releases be revoked or suspended several times. (...) Groleau is serving a sentence that began in December 1995 for a seven-year prison term he received after he pleaded guilty to a series of armed robberies carried out on the South Shore. He saw that seven-year sentence gradually be increased to his current 24-year sentence after having committed a long series of offences while out on parole or other forms of releases. (...)The statutory release he qualified for last year was suspended in May after Groleau missed the curfew at his halfway house and authorities suspected something was up when he finally showed up at 2 a.m. (...) Montreal Gazette

#### Some court cases to watch for in 2020

At the end of January, Quebec's Court of Appeal will hear arguments on the sentence of Alexandre Bissonnette, who killed six men at the Islamic Cultural Centre in Quebec City in January 2017. He pleaded guilty in March 2018 to 12 charges - six of first-degree murder and six of attempted murder with a restricted weapon and was sentenced in 2019 to a minimum of 40 years in prison - a sentence he has appealed. He is asking to be eligible for parole after 25 years. The Crown is asking for a minimum sentence of 50 years. Initially, it had asked for 150 years. (...) Montreal Gazette

Manitoba MLA wants poems by convicted killer removed from Parliamentary Poet Laureate website

A member of the Manitoba legislature wants the Canadian heritage minister to remove two poems from the Parliamentary Poet Laureate website that were written by the killer of an Indigenous woman. Nahanni Fontaine says the inclusion of works by Stephen Brown, including one about a prostitute, constitutes "blatant disrespect" for Brown's victim as well as missing and murdered Indigenous women and girls. Brown, who changed his name from Steven Kummerfield, was convicted of manslaughter in the 1995 beating death of Pamela George, a First Nations woman. The two pieces are among "Poems Selected by George Elliot Clarke" on the website and were posted in 2017 when Clarke was parliamentary poet laureate. (...) 18 Ontario Provincial Police and Correctional Service Canada have teamed up to produce a public service announcement asking for the public's help to combat the use of drones that drop contraband inside area institutions. The tweet put out by the OPP East Twitter page on Monday shows a video of OPP Joint Forces Penitentiary Squad acting Sgt. Joel Blacklock standing in front of the west wall of the closed Kingston Penitentiary speaking about local drone activity. In the almost two-minute video, Blacklock said the correctional service and the penitentiary squad remain vigilant in stopping the smuggling of contraband into federal institutions. (...) 25 A federal correctional service officer who got sick and collapsed at work last September under the influence of methamphetamine has been placed on probation for 12 months and ordered to perform 30 hours of community service and to complete assessments, counselling and programs of rehabilitation as directed by her probation officer, especially for substance abuse. Marni Thompson, 45, pleaded guilty in Kingston's Ontario Court of Justice earlier this year to illegal drug possession relating to four white pills stamped "ICE" that she had in her pocket when she went into medical distress on the grounds of Collins Bay Institution on Sept. 12, 2018. The pills were later determined on analysis to be methamphetamine. #### Court adjourns convicted man's quest

Sheepway is serving a life sentence, with no eligibility for parole for 13 years, for the killing of Christopher Brisson in 2015 in Whitehorse. Sheepway's lawyer, Vincent Larochelle, expressed some concerns about the Yukon Legal Services Society revoking his client's certificate for legal aid over the costs for the trial transcript. (...) #### Seizure of contraband at Dorchester Penitentiary - Medium security unit

On January 2, 2020, staff members confiscated one package containing contraband in the medium security unit at Dorchester Penitentiary. This seizure is the result of the combined efforts of correctional officers. The contraband seized includes 21 Nicotine patches. The total institutional value of this seizure is estimated at \$2,600. The Correctional Service of Canada (CSC) is heightening measures to prevent contraband from entering its institutions in order to help ensure a safe and secure environment for everyone. CSC also works in partnership with the police to take action against those who attempt to introduce contraband into correctional institutions. CSC has set up a telephone tip line for all federal institutions so that it may receive additional information about activities relating to security at CSC institutions. These activities may be related to drug use or trafficking that may threaten the safety and security of visitors, inmates and staff members working at CSC institutions. ### Four inmates accused of attack inside Burnside jail lose bid for more freedoms

Four of the 15 inmates accused of viciously beating another inmate at the Central Nova Scotia Correctional Facility have had their request to move out of a highly restricted unit of the jail turned down by a judge. (...) They said their detention in a reintegration unit with intensive direct supervision has deprived them of their liberty because they've been confined to their cells for between 22 and 24 hours a day. They said it severely limits their time to do things like call their families, contact their lawyers, get exercise and enough food. (...) The four accused have been in the unit ever since the brutal beating and stabbing of a 46-year-old inmate on Dec. 2, 2019, except for Cox, who was recently moved to a close confinement unit following the discovery of contraband in his cell. The attack happened in North 3, a general population unit, where at least 15 inmates formed a human wall to stop guards from getting to the victim of the attack. (...) Ross said the attack has led to a serious staff shortage. He said around 18 staff members are calling in sick or refusing to work each day under occupational health and safety rules because of the security risk they feel from being short-staffed or from the inmates themselves.
