Sorry [REDACTED] for not getting back to you I am hoping to have a discussion with the RDC as he has been away all this week.

1) No issues with drone shooting both interior and exterior. As long as all of the permits, insurances and approvals are taken. Do you have a signed agreement yet for the video?

2) We have been working with the United Way and have employees dedicated to the project itself so we could ensure that someone would be available instead of hiring Commissionaires. I think it is a good idea for consistency to have a signed agreement with the city regarding the filming itself as the agreement between CSC and United Way is silent in this area. It only speaks to the music event itself. Obviously the filming itself and the use of drones during the event set-ups an added liability which I believe is better captured under the filming contract. I have attached the agreement between CSC and United Way for the "music event" from September 10th through September 17th.

I think the detailed plans are important if there are plans to film before during or after the prescribed dates as well.

Hey Wayne,

I just wanted to go over 2 quick things with you when you have a minute:

1 - The Headstones Music Video wants to do some interior drone shooting as part of their video Monday. I told them I would talk to you about approvals. They originally were looking at 6 drone operators but I've got it down to 2 with Sgt Darren Keuhl as the lead, which makes me feel a lot more comfortable. They would have all necessary Pilot Certificates, Nav-Can Approvals, and Insurance Certificates naming the City, CSC, SLPC and TK. Let me know if you prefer exterior only and I can restrict them to that.

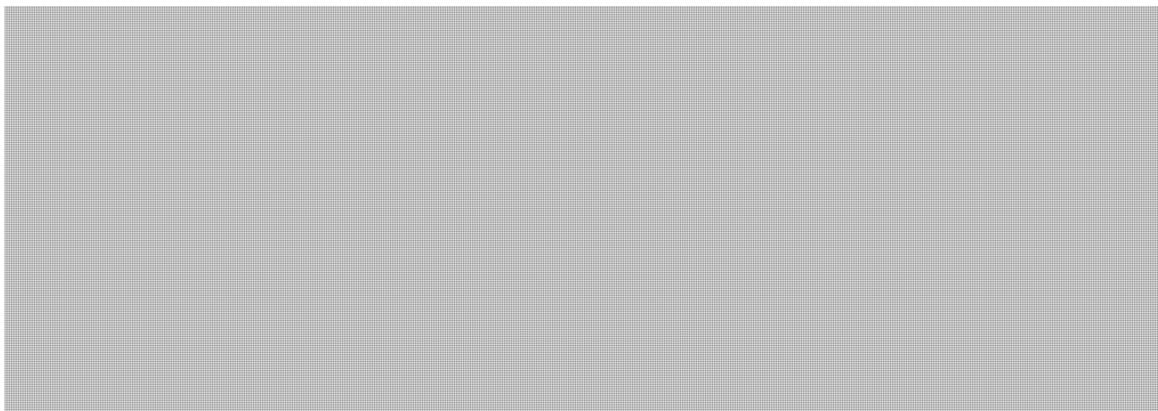
2 - The United Way didn't know about film permit needs. Per my email to them below, there's no cost and I'll make it super simple - I just want to make sure that all parties are protected and proper permissions and insurance is in place. I

also want to make sure that the filming plans are outlined/restricted, so the Production Company can't just go ahead and use the footage for non-approved uses (like selling b-roll to other non-approved productions).

I can make it as easy as possible but still think it would be worth going through the full film rental agreement at no cost, so all the legal terms are included and we're all protected, but I wanted to get your steer. Same on whether you feel the need to have [REDACTED] Commissionaires or the KFO on-site for filming (part of why I want their detailed plans like any other production, to make sure - just being extra cautious).

Hi Bhavana,

Very nice to meet you. I'm clear for a call anytime until 1:00 or from 3:00-4:30 at [REDACTED] (I just may have spotty cell reception while on the train the next half hour).

My apologies in advance if I don't have a lot of details or if some of this is redundant - I've requested more information from [REDACTED] at SkEye Stream and [REDACTED] but haven't had much response, so glad to be in touch directly.

We handle the film side for both CSC and the City on KP, facilitate the process and make sure everyone's interests are served. There's no cost for the actual permit. Usually there's a rental cost for the facility, but I'm sure that's covered/waived with CSC. The only potential cost would be if there are any Commissionaires required to supervise filming specifically, but I suspect you have that covered (and I may well be able to have someone on the Film Office side attend if need be to avoid any cost - I can also potentially help out with some student volunteers). So it should just be a simple free permit.

**PERMIT REQUIREMENTS:**

-A synopsis of what's being filmed (to protect the stakeholders representation, and ensure the footage doesn't get used for other purposes) -Insurance Certificates naming the City, CSC, SLPC and Tourism Kingston on a \$5,000,000 policy (I'd imagine CSC is already covered, and we can likely waive SLPC and possibly the City) -Pilot Certificate, Nav-Can Approvals and same Insurance Certificates from Drone Operators

I'll ask CSC and the City if they need the usual full agreement signed (fees waived of course) or if they can just use a simple one pager. The application form is very simple at [www.filminkingston.ca](http://www.filminkingston.ca)

Here is a breakdown of the communications and the events of the last week and a half regarding the United Way Music event.

2019-04-09 Following our meeting at the UW office and possible discussion on the potential music event UW look at insurance for this type of event and asked that we comment.

2019-04-09

2019-04-09 Reached out to real property who stated we should start with a proposal from the UW.

2019-04-09 Sent message to UW asking for a proposal so we could discuss with real property and draft a license agreement.

2019-04-30 Received message from UW regarding a poster/ad mat regarding the event. Reached out to Amy/David at NHQ for input/comments and provided feedback.

2019-05-01 Received e-mail from UW providing the proposal and stated that "We will need to move our launch dates ahead – we are hoping to announce the concert next week on May 8th and start ticket sales on the 11th of May".

2019-05-01 Given the proposal drafted a license agreement using previous agreements with the city and sent to NHQ legal and real property for comments.

2019-05-01 Spoke with Amy who was going to brief the Commissioner.

2019-05-02 Received e-mail from Amy indicating she raised at morning ops with CS and Legal had let the Commissioner suite know and that she would do a signal check with the MO.

2019-05-02

They were going to explore further to how we did the previous agreements with the city.

2019-05-03 Provided Real property information on percentage use of the facility for the tours and the proposed music event.

2019-05-04/05 Reconfirmed that Commissioner office and the MO was aware.



2019-05-07 Asked CS for an update received message "[REDACTED]  
[REDACTED] Note that the goal is still to allow the use of KP by the city and organizations in order to promote the use of the site."

2019-05-07 Sent message at the end of the day. "I have spoke with the United Way, President & CEO this afternoon and explained that both the Commissioner's office and the Minister's office are supportive of the event however the final agreement is not yet signed pending the review and [REDACTED]  
[REDACTED]....." The CEO has indicated the criticalness to proceed with the announcement as planned for tomorrow, knowing the agreement is yet to be signed, has indicated they will be announcing publicly the plans for the event in September."

2019-05-07 Received message from Amy " OK; I will flag this to the Commissioner so she is not caught off guard by the announcement, noting that MO did not have any concerns. Will cc you, Scott."

2019-05-08 Sent message 5:33 am to UW asking if they could hold off. Received a call from UW stating that it was too late that the announcement had gone out premature from outlets and that the official launch announcement were happening at 7am.

#### **Bands to rock in the joint**

The prison that once held some of Canada's most notorious criminals will be hosting some of the country's best-known musicians for a fundraiser this fall. "Rockin'the Big House" will see the Headstones, the Trews, the Pursuit of Happiness, and Kasador - along with special guests Paul Langlois, Gord Sinclair and Rob Baker of The Tragically Hip, and Tom Cochrane - perform inside the walls of the now-closed Kingston Penitentiary on Sept. 14 in support of the local chapter of the United Way. Each of the bands is playing for free. Tickets for the event go on sale May 11 and will be available online through [rockinthebighouse.ca](http://rockinthebighouse.ca) and [ticketmaster.ca](http://ticketmaster.ca). There will be a limited number of gold tickets, which offer a closed-off section with separate food and beverage service as well as portable washrooms, for sale, while general admission tickets will be \$75 apiece. Platinum tickets sold to sponsors were gone within a day. Organizers expect tickets, which they hope will raise at least \$250,000, will sell out quickly. The concert, for which a total of 2,500 tickets will be sold, is to take place outdoors in the courtyard closest to King Street. (...) There was already a connection between Correctional Service Canada and the United Way, as the former has directed proceeds from the popular Kingston Penitentiary tours to the latter. "It just seemed like we should float this idea and see where it goes," Varma said. Last month, Scott Harris, regional deputy commissioner of **Correctional Service Canada** and a longtime supporter of the local United Way, was named the chair for the 2019 United Way campaign. "We figured that with the involvement of the United Way, the community, and the people involved, that we would be able to get that to happen with Scott (Harris), and it was a slam dunk," Murphy said. "We're over the moon about it." Langlois and Murphy - who, along with Chris Murphy, are co-chairs of the event - wanted to do an event that appealed to a younger crowd, was more inclusive, and was a bit bigger in scale. #### **Victims angry convicted killer making bid for early parole**

**WARNING:** This story contains graphic content. Nancy Brace doesn't mince words when it comes to describing the man who attacked her on a Halifax street in 1990: "He's a monster." (...) The letters Brace refers to are notices from the **Correctional Service of Canada**. As one of Lavoie's victims, she signed up to receive notifications any time there's a development in his case. She received one of those notifications a few days ago, telling her Lavoie is applying for early release from prison for another crime he committed. Lavoie has a history of violently attacking women. He has been serving a life sentence for the 2004 beating death of Sharon Ann Hatch. While out on bail for assaulting Brace, he attacked a 16-year-old girl he knew, kicking her, punching her and stabbing her three times. Brace stays in touch with the other victim, who's now a 44-year-old woman. Brace said the other victim suffers from post-traumatic stress disorder and plans to file her own letter with the Parole Board of Canada. (...) Like Brace, Harnum is convinced that Lavoie will offend again. Harnum said if given the option, she will appear at any hearing the parole board conducts in Lavoie's case to make her objections in person. [CBC News](#)

#### **Incarceration's health toll 'staggering': report**

Commentary suggests entire communities ravaged by disproportionate Indigenous prison population The over-incarceration of Indigenous people is harming their health, local experts argue in a report calling out a public health "crisis" in Manitoba. "When you have so many people from one identifiable group that goes through this experience of incarceration, that has effects on the entire community," said Davinder Singh, who co-authored a commentary for the

*Canadian Medical Association Journal*. The report argues the health effects of a year behind bars knocks off two more years from the average person's life expectancy due to issues such as depression, infections and heart disease. With a disproportionate number of First Nations and Métis adults sent to prison - a rate that is 18 times the rate for the rest of Manitobans - the effects are ravaging entire communities, the researchers argue. Singh, a researcher from the University of Manitoba, wrote the two-page report alongside a university colleague and a policy expert from the Winnipeg Regional Health Authority. Le gouvernement du Canada a publié lundi des appels d'offres visant à acquérir des systèmes de détection de drones pour certains établissements du **Service correctionnel du Canada (SCC)**. Les appels d'offres, qui sont ouverts jusqu'au 3 juillet, précisent que ce sont des Systèmes de détection des intrusions aériennes et terrestres (AGIDS) qui sont recherchés pour six établissements, dont ceux de Cowansville, en Montérégie, et de Donnacona, près de Québec, de même que celui de Dorchester, au Nouveau-Brunswick. Ces systèmes cherchent à prévenir la livraison d'objets interdits par des personnes ou par des drones, précise-t-on. **Questions:** Sorry to do this, but I have some questions about another aspect. I've been reviewing the "[Corrections and conditional release statistical overview](#)" reports, particularly Figure and Table E4, which deals with long-term offenders. It talks about the proportion of offenders that have at least one "current" conviction for a sexual offence. What is meant by current? Is this the offence for which they were deemed a long-term offender? Or is it something else? I also have a question about the column "LTSO interrupted." The footnote says this category "includes offenders convicted of a new offence while on the supervision portion of an LTSO." Is this the only thing the category includes? Does it also include offenders charged and on provincial remand awaiting trial, or suspensions that don't result in criminal charges? For those where convictions resulted, is there a breakdown of the offences? ie. Violent, sexual, property, breach under Criminal Code. There also seems to be a significant uptick in 2016 and 2017 in LTSO interrupted? What's the explanation for this? One last thing. I know your colleague said Corrections can't accommodate an interview. In understand Corrections can't speak about Watts in particular due to the Privacy Act. Would it be possible to do an interview more generally about how long-term offenders are managed in the community?

#### **Federal prisons taking aim at special (illicit) deliveries from the sky**

Prison wardens are usually preoccupied with keeping people inside their walls. Now six Canadian prisons are taking steps to shoo away some pesky, flying visitors. The Correctional Service of Canada has earmarked \$6 million for electronic systems to prevent tiny drones from dropping illegal drugs, cellphones or other contraband into the yards of its institutions. The prison service is alarmed by cases of small, easily purchased flying devices delivering forbidden items weighing up to five kilograms to prisoners from the air. Stephanie Ray, 46, pleaded guilty in Kingston's Ontario Court of Justice to committing a breach of public trust, which carries a maximum liability of five years imprisonment. Ray's sentencing was suspended, however, and Justice Alison Wheeler indicated that she'd considered discharge, given Ray's age and lack of any prior criminal record. #### **Goodale disputes charge that bill maintains solitary confinement by another name**

Public Safety Minister Ralph Goodale is disputing claims that a bill to end solitary confinement in Canada's prisons is merely "linguistic trickery" that maintains the practice under a different name. Goodale told a Senate committee Wednesday that Bill C-83, which would create new "structured intervention units" to replace segregation units is "not just semantics." There will always be a need to separate some inmates from the general prison population, for their own safety and that of other prisoners and guards, he said. But he maintained the bill would do so in a much more humane way than occurs now. Currently, inmates are confined to their cells for up to 22 hours a day "with little or nothing in the way of meaningful human contact or rehabilitative programming," Goodale said. ### **Faux Nation inmates make farce of prison**

A columnist states, "It has been seven months since we learned of **Correctional Service Canada's** jaw-dropping decision to transfer Terri-Lynne McClintic to a zero-security healing lodge for Indigenous women, just eight years into her minimum 25-year sentence for the first-degree murder of eight-year-old Tori Stafford. Well, OK, not exactly "zero security." It's just that actually preventing escapes is not within security staff's purview - as was helpfully illustrated by inmate Joely Lambourn, who walked away from the facility amidst the controversy. remarkably, in the bewildering cavalcade of things that were wrong with her move - which was later reversed after Public Safety Minister Ralph Goodale requested (cough, cough) **CSC** review the matter - the fact that McClintic is almost certainly not in any meaningful sense Indigenous could barely crack the top five. Over the weekend, Isabelle Hachey of La Presse brought us another astonishing tale from Canada's prison system. This time, inmates' Indigenous identity is the crux of the issue. "hundreds of Québécois criminals are declaring themselves Aboriginal as soon as they enter prison," Hachey reported, which "gives them certain advantages, such as more frequent spousal visits and faster reassessment of their security classification" - i.e., faster access to the exit door.
